## 2023年北京论坛国际关系分论坛 "不确定时代的国际合作与全球治理" 会议议程

#### 会议背景

当前,世界之变、世纪之变和历史之变正以前所未有的方式展开,全球 化、技术变革、环境风险和地缘政治失稳让世界进入深度不确定性的时代。今 天的世界面临着复杂而相互关联的挑战,这些多维度多方面的挑战,亟需全球 集体行动来加以应对。与此同时,深度不确定性意味着各类行为体都必须基于 不完整或相互矛盾的信息做出决策。这些复杂挑战和深刻变化超出了特定的国 家或地区、让全球的安全和发展前所未有地结为一体,因此国际合作和全球治 理至关重要,否则将难以实现减少冲突和促进可持续发展的共同目标。

然而,不确定性从来都是国际合作和有效全球治理的主要障碍之一。虽然 不确定性可以创造紧迫感、为各国合作提供共同动机,但它也可能导致迟疑不 决、缺乏信任和协调困难。此外,基于证据的全球治理必须更多地将不确定性 考虑在内,在根据可用证据做出决策的同时,承认其局限性和潜在风险。换句 话说,全球治理必须在确定性需求和不确定性现实之间取得艰难的平衡。

促进国际合作和全球治理以应对不确定性,亟需解决以下关键性问题:如 何在面对不确定性和分歧时促进国家之间的信任和合作?如何加强国际组织和 机构的能力,以支持面对不确定性的合作和治理?国际合作和全球治理中如何 在有限或相互矛盾的证据下达成尊重科学和政治现实的共识?如何在国际合作 和全球决策的决策和进程中促进创新和创意,以确保我们能够适应和应对不断 变化的情况和风险?如何在公正和可持续的方式下平衡个人、社区和国家层次 上不同利益相关者的需求和利益?如何建立地区、国家和全球的适应性和韧性 机制,以确保我们能够更好地应对未来的危机和不确定性?等等。

本分论坛由北京论坛与北京大学国际关系学院共同举办,旨在通过汇聚相 关领域世界知名学者的见解和专业知识来探讨以上关键问题。

## International Cooperation and Global Governance in the Era of Uncertainty Beijing Forum 2023 Agenda

#### Background

Currently the changes of the world, the century and the history are being unfolded in an unprecedented way. We have entered an era of deep uncertainty mainly driven by globalization, technological change, environmental risks, and geopolitical instability. Our world today is faced with complex and interconnected challenges that are multifaceted and require significant collective action from the global community to address. Deep uncertainty also means that public and private actors must make decisions based on incomplete or conflicting information. In the era of uncertainty, international cooperation and global governance are critical in addressing the complex challenges which are not confined to any particular country or region, and therefore require collective action from the global community. Without effective cooperation, it would be difficult to achieve shared goals, reduce conflicts, and promote sustainable development.

However, uncertainty has long been identified as one of the major obstacles to international cooperation and effective global governance. While uncertainty can create a sense of urgency and provide a shared incentive for countries to cooperate, it can also lead to hesitation, mistrust, and a lack of coordination among countries. Also, evidence-based global governance must take into account uncertainty and make decisions based on the best available evidence, while acknowledging the limitations and potential risks. In other words, global governance must balance the need for certainty with the reality of uncertainty.

In order to address uncertainty and promote global governance through international cooperation, there is an urgent need to address the following key issues: how can trust and cooperation be fostered between nations in the face of uncertainty and disagreement? How can the capacity of international organizations and institutions be strengthened to support cooperation and governance in the face of uncertainty? How can consensus be reached on respecting science and political reality



in the face of limited or conflicting evidence in international cooperation and global governance? How can innovation and creativity be promoted in the decision-making and processes of international cooperation and global decision-making to ensure that we can adapt and respond to ever-changing situations and risks? How can the needs and interests of different stakeholders at the individual, community, and national levels be balanced in a fair and sustainable manner? How can adaptive and resilient mechanisms be established at the local, national, and global levels to ensure that we can better respond to future crises and uncertainties, and so on.

This forum aims to tackle these questions by gathering insights and expertise from world-renowned scholars in relevant fields.

Her work has appeared in International Affairs, European Journal of International Relations, World Development, Development Policy Review, Studies in Comparative International Development, Review of International Political Economy, New Political Economy, China International Strategy Review, and The Oxford Handbook of Industrial Policy. At Peking University, she teaches International Development Policy (undergraduate) and China and Global Development (graduate).

Muyang holds a Ph.D. from the University of Washington, an M.A. from the University of California, Berkeley, and dual bachelor's degrees from Peking University



and Waseda University. She was a research fellow at the Global Development Policy Center of Boston University and a visiting scholar at Japan's National Graduate Institute for Policy Studies.

He also serves as doctoral advisor and post-doctoral research advisor at CCPS/CNAG. His research focuses on international strategy and security, China's foreign strategy, US relations with the Islamic world, and the Middle-east issues, etc. He participated in a series of major research programs on topics including China's pursuance of peaceful development, the Basic Issues of Xi Jinping Thought on



Socialism with Chinese Characteristics for a New Era, Xi Jinping Thought on Foreign Affairs, and Xi Jinping's Statements on the Concept of Comprehensive National Security, etc. He has published a number of books and over a hundred scholarly papers.

Social part-time jobs include a member of the first National International Affairs Professional Degree Graduate Education Guidance Committee; Vice President of the International Political Research Association of Beijing Universities; Member of the United Nations Association of China.

Before joining the faculty of Peking University, Prof. Pang was Assistant Professor in the Department of Politics at Princeton University, Associate Professor and then Professor in the School of Social Sciences at Tsinghua



University, the co-director of the Carnegie-Tsinghua Global Policy Center, the vice dean of Tsinghua's Institute for International Relations Studies, the visiting research scholar at the Niehaus Center for Globalization and Governance at Princeton University, the director of . the Central Committee for Young Leaders of the China Democratic League, and the associate editor of World Politics. Prof. PANG's research interests include theories and methods for global risk politics, international organizations and global governance, sustainable development, Bayesian statistics and causal inference in social sciences. Prof. Pang received her B.A. and M.A. from Peking University and Ph.D. from Washing University in St. Louis.

He was awarded the Honorable Mention of the Russian Federation and the Ordre National du Mérite of France.

She previously was Assistant-Secretary-General of the United Nations and Executive Director of the International Trade Centre (2013-2020). Between 2005 and 2013 she served as Chief of Staff to the Director-General of the World Trade Organization, Pascal Lamy. Before that she held senior positions at the European Commission in the areas of international trade and development. Ms. Gonz alez started her career as lawyer in the private sector. Ms. Gonz alez has been a member of PSIA's Strategic Committee since 2017.

#### **Benjamin E. Goldsmith**

Professor in the School of Politics and International Relations at the Australian National University. At the China Institute, in addition to overseeing the operations, she leads policy research initiatives examining Canada's diplomatic, trade, investment and energy linkages with China. Jia also provides strategic and policy advice on China to University senior leaders as well as executives at public and private sector organizations.

#### **Philippe Rheault**

A lawyer and diplomat, L. Philippe Rheault takes on the leadership of The China Institute following a 25-year career in the Canadian foreign service, where he mainly focused on China and East Asia. He has been posted to the region six times: to Beijing, Taipei, Chongqing (twice), Mongolia, and Guangzhou.
